## MINUTES OF THE ANNUAL MEETING January 24, 2021, via Zoom

St. Paul's Episcopal Church Vergennes Annual Meeting January 24, 2021 On Zoom

Present: Rev. Sherry Osborn, Deacon Lucy Pellegrini, Senior Warden Rebecca Chauvin, Junior Warden Chris Hale, Treasurer John Stroup, Katy Arend, Marsha Arend, Madelaine Calise, George Chauvin, Sarah Cowan, Laurie Earle, Tim Earle, Mary Gordon, Nan Guilmette, Kim Hatgen, Bob Laidman, Cricket Laidman, Margaret Lowe, Steve Lowe, Jeff Mangini, Sarah Mangini, Dave Merrill, Diane Merrill, Lenore Morse, Bo Price, Sarah Stroup, Judy Woods.

Initially, Rev. Sherry Osborn offered prayers in support of the discussion and motions by the St. Paul's parish family during this Annual Meeting, the preceding followed by the call to order by Senior Warden Rebecca Chauvin at 10:30 a.m., January 24, 2021. Second, Rebecca requested a motion regarding the minutes of the January 2020 Annual Meeting. Sarah Cowan made the motion to accept the minutes of January 2020 as submitted in the 2020 Annual Report; the motion was seconded by John Stroup and with no corrections, the motion was voted and passed unanimously.

Next, Rebecca turned to the nominations for three-year terms on the vestry. For the vestry nominating committee, Bo Price nominated Rebecca Chauvin, Nan Guilmette, and Kim Hatgen. Steve Lowe made the motion to close nominations, seconded by John Stroup. The motion passed unanimously, then Steve Lowe made the motion to vote for the slate of three nominations: Laurie Earle seconded the motion and all present voted aye.

For delegates to the Diocesan Convention, Rebecca Chauvin reported the nomination of Nan Guilmette, Sarah Mangini and Lenore Morse. Steve Lowe moved to close the nominations, second by Madelaine Calise; the motion was voted and passed unanimously. Tim Earle moved to vote in favor of the three nominations for delegates to the Diocesan Convention 2021; the motion was seconded by Bob Laidman. The motion to elect Nan Guilmette, Sarah Mangini, and Lenore Morse as delegates to the Diocesan Convention 2021 was voted and passed unanimously.

Turning to the nomination of alternate delegates to the Diocesan Convention, Rebecca nominated Mary Gordon, Bo Price and Sarah Stroup, and Steve Lowe made the motion to close nominations. Tim Earle seconded the motion and the motion passed unanimously. Tim Earle made the motion to elect the three nominees, and Madelaine Calise seconded the motion. The motion to elect Mary Gordon, Bo Price, and Sarah Stroup as alternate delegates was voted and passed unanimously.

With elections completed, John Stroup explained the Budget for 2021, passed by the vestry at their January meeting. Beginning with the bottom line as reported on page three, John indicated a probable surplus, an estimated income of \$87, 854 (total income projected as \$109,559.62) and estimated disbursements of \$78,216.89 for 2021. Relative to line item 1404-3, pledges for 2021 are up. Further, he noted line item 1702, donations that support local, national, and international charities, which are now 4.3% of the operating budget for 2021. This amount represents a steady increase in St. Paul's organizational giving over several years, in both percentage and amount. The budget item 1736, telephone, and broad band, is an increase to cover Wi-Fi services, which will serve both St. Paul's and possible community sharing. John inquired whether there were any questions, and Bob Laidman reported a recent increase in pledges, line item 1404-3, to a total of \$58,358, a change since the vestry approved the budget. Madelaine Calise inquired about the current amount of the Swift Fund, and John replied that the current amount for St. Paul's Diocesan Unit Funds is \$362,660.47. Unit Funds are held by Hickok and Boardman in Burlington. In sum, while some funds have been withdrawn, the principle has increased in line with stock market increases. John added that with a balanced budget anticipated this year, there should be no reason to withdraw funds from the Swift Fund. Budget totals appear on page three of the Budget Report as follows: total of all disbursements budgeted for 2021 is \$78,216.89; the operating income less the operating expenses is estimated at \$8,127.11; the total estimated income less total estimated expenses is \$9,637.11. In sum, the projected 2021 budget indicates a possible surplus.

Bo Price asked what the original bequest from George Swift was. John stated that approximately \$15,000 had been withdrawn from the Swift Fund, which is an unallocated fund. John also added that the current loan listed as an SBAPPP Loan from the Middlebury National Bank will be settled by Sarah Cowan as soon as possible.

Sherry expressed the gratitude of St. Paul's members to John Stroup for many years of exceptional service as treasurer. Sherry added that John is also a very active member of the community, for example, as the chairman of the Addison Northwest District School Board.

Next, Sherry announced that Rebecca Chauvin has agreed to continue serving as Senior Warden, a major contribution to the parish, especially as the vestry considers the potential of calling a new priest for St. Paul's.

For the first time, for the Annual Meeting 2021, Sherry introduced use of the service of Commission of the Vestry and Wardens. Following the initial prayers and blessing, Sherry called the vestry and wardens to accept this commitment to serve and asked the parish to agree that these persons are prepared to do so. In closing, Sherry welcomed the vestry members and the Sr. and Jr. Warden with further prayers.

Rebecca requested any further New Business and with none indicated, Steve Lowe made the motion to adjourn the business portion of the 2021 Annual Meeting. The motion was seconded by George Chauvin, voted, and passed unanimously. The 2021 Annual Meeting adjourned at 11:05 a.m. The parish joined in singing the hymn, "I Danced in the Morning", Sherry offered the blessing, and Lucy dismissed the gathering.

#### **SENIOR WARDEN REPORT**

2021 was another year of transition for St. Paul's. Due to the ongoing pandemic, we began the year worshiping remotely on Zoom, then as the weather got nicer, we enjoyed some outdoor services, before finally returning to in-person services inside of our church building in early August. This was both an exciting time as well as a somewhat apprehensive time. While we celebrated being together in our church building again, the preparations that went into getting us there were full of tough decisions around keeping our congregation safe. As senior warden I worked closely with Sherry and the Vestry to make sure that we were adhering to the safety protocols and guidance from the state and our diocese. Hours were spent meeting about air filtration, fans, physical distancing, signage, and mask-wearing within our sanctuary. Much time was also put into upgrading our church Wi-Fi connection and getting computer and sound system equipment in place and ready to securely stream our in-person services on Zoom. Through these careful preparations and the hard work of many, we were able to celebrate the joyous occasion of once again worshiping inside our church building. And while in-person services have been attended by many since our reopening in August, we respect that there are some parishioners that cannot or choose not to attend, and because of this we have made it a high priority to continue to offer and improve streaming our worship services via Zoom.

The Vestry also spent a majority of time over the last year reflecting on our needs as a parish, reviewing the parish-wide survey results and other feedback received from our congregation, and what this meant in terms of the call of our next clergy person. Once our Ministry Discernment Committee was formed in March, the Vestry worked with them to identify the most pressing parish priorities so that the formal call could then be made for a half-time clergy person.

As our interim time with Sherry and Lucy concludes we are reminded of our many blessings at St. Paul's. To have their leadership during the interim time–during this pandemic, during what have

probably been some of the most difficult times for many of us—was truly a blessing. Through their guidance we have been reminded to witness and recognize the gifts, skills, and love within each one of us at St. Paul's, and we've been encouraged to courageously share these gifts with the rest of the congregation, with our neighbors, and with the world.

As we head into this new year and this new season of our church life, we once again are faced with much uncertainty - around the pandemic and how it will continue to shape our shared church life, around our next settled clergy person, around our aging buildings and the difficult conversations and decisions ahead, and around the overarching question of how, through all of these challenges, we will continue to be God's hands in the world. I am reminded often that one thing is certain, the faith community of St. Paul's is passionate, we support one another, our talents and energies complement each other, and as the Holy Spirit moves through us, we continue to be God's light for each other as we move forward into this new year.

#### **JUNIOR WARDEN REPORT**

Rectory

As the result of a professional inspection of the Rectory building's current condition, The Deep Dive Rectory Committee has recommended that clergy not be housed there.

And if we are not going to invest a significant amount of our resources in the building to address all the issues that have been identified, it makes sense to follow the advice of the real estate consultant hired by the DDR and sell the property as-is. One interested party that we are hopeful about a potential purchase is the John Graham Shelter. They have recently toured the property with their architect and are excited by the possibility of expanding the housing they provide that is so badly needed by homeless families in our community. There are many details and obstacles to be figured out, but if things go down that path a special parish discussion will take place to determine if and when that might happen.

#### Church

- 1. The bell tower and roof line painting quote we got back in 2019 has been revisited and there are plans to begin as soon as warm weather returns.
- 2. Wi-fi has been installed in the sanctuary, and a new emergency door that opens and closes easily.
- 3. The Opera House is planning on installing an elevator in the back alley, as well as improvements to the entire space with plantings, benches, and lighting improvements. They are including the church since we share the alley, and have begun architectural charrettes which include the work already done by the SISP committee. Stay tuned for updates.
- 4. The day before Christmas Eve a filtering device was added to our heating system that reduces COVID transmission by passing the air over an ultraviolet light.

#### MINISTRY DISCERNMENT COMMITTEE REPORT

In March 2021, St. Paul's constituted a Ministry Discernment Committee (MDC) to lead the process of calling our next clergy. With guidance from the Episcopal Diocese of Vermont, a three-member MDC

was created and provided guidance about how to proceed through the various stages. The Vestry provided guidance about the resources available, suggesting a half-time clergy person was financially responsible yet able to meet our parish needs. Over the summer, the MDC met regularly to complete a "Parish Profile" (now available on the St. Paul's website), led discernment conversations with the congregation in late July, and learned how these resources would be shared with interested candidates. The pandemic and other hurdles led to a slower process than we hoped. By late fall, however, the MDC had posted its job advertisement, worked with a new Diocesan liaison, and learned about other Vermont parishes seeking new leadership. As we enter 2022, we are grateful for the excellent leadership we have enjoyed and hopeful about attracting candidates. Stay tuned!

#### **DEEP DIVE RECTORY COMMITTEE (DDR) REPORT**

The DDR committee was formed after the Vestry and Ministry Discernment Committee (MDC) concluded it was in the best interest of St. Paul's to examine the potential use of the Rectory, including its continued use as clergy housing. A great deal of discussion had ensued in the past among the congregation on alternative use of the Rectory, particularly if future clergy chose not to occupy the building. All parishioners were invited to join the committee, as announced over zoom and through church bulletins. Some parishioners had already expressed an interest in future Rectory discussions, as seen in past surveys. The four committee members who came forward were: Madelaine Calise, Sarah Cowan, Mary Beth Hamilton, and Bo Price. The committee spent six weeks in July and August 2021 in meetings and through emails gathering information that would help to determine the best choice or choices for the Rectory use. An informal recommendation was made to the MDC at the end of August.

Due to the findings of the building inspection report and the real estate report which the DDR obtained, the DDR concluded that no one should be living in the Rectory at this time due to multiple issues that made the building unsafe and essentially a liability for St. Paul's. The MDC and Vestry concurred that no one should be living in the building at this time. A presentation on the progress of our ministry discernment and calling of a new 1/2-time clergy was made to the parish mid-November, which included these rectory findings.

The DDR also made some basic recommendations beyond the current clergy housing question. The DDR's detailed recommendation can be found here. https://docs.google.com/document/d/1kLOAVEgHSY9aOl8iGhFbhm\_wnPnuIEHQ0YGWJUoTPJE/edit

Essentially, because of the costly repair of the Rectory, the DDR recommended that St. Paul's seriously consider selling the property, which is a complicated process that takes a vote from the parish, under very specific diocesan rules. The DDR further recommended that if St. Paul's felt that a sale was not in their best interest, then St. Paul's needed to develop a plan for repairing and rehabilitating the building. The cost would be substantial. For example, one item needed right now is a new roof. Even to fix and keep the Rectory for rent or lease, multiple repairs are required.

There are no plans to do anything with the Rectory until a parish-wide conversation takes place where people can have access to all the facts and make informed decisions.

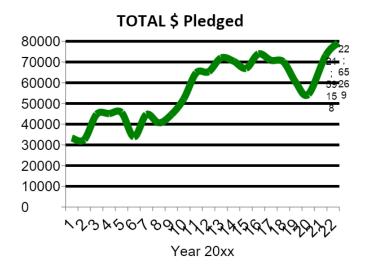

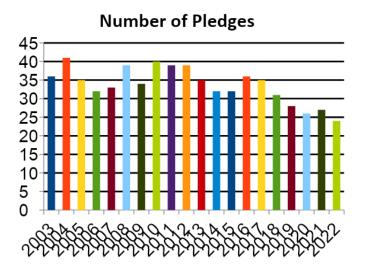
